Citizenship Process Expedited for Service Members

The Department of Homeland Security recently expedited and streamlined the citizenship process for men and women serving in the Armed Forces. The rule amends DHS regulations to reduce the time requirements for naturalization through military service from three years to one year for applicants who served during peacetime, and extending benefits to members of the Selected Reserve of the Ready Reserve of the U.S. Armed Forces. Service members who have served honorably in an active-duty status or in the Selected Reserve of the Ready Reserve for any time since Sept. 11, 2001, can file immediately for citizenship. Department of Veterans Affairs to Survey Veteran Households

The VA is launching a national survey of veterans, active duty military members, activated National Guard and reserve members, and family members and survivors to learn if they are aware of VA services. Currently, the VA is mailing out survey screening information to more than 130,000 households to identify potential survey participants. Those identified as being eligible may be asked to

participate in a full length survey. This will be the 6th VA National Survey of Veterans since 1978. The data collection is expected to be finished by the end of February 2010 and a final report issued in December of 2010. Post Commander Kern encourages any Post member receiving information to complete it and return it. The importance of doing so for all fellow veterans cannot be overstated.

Post Member and Pearl Harbor Survivor Receives Visit

Post 259 member and Pearl Harbor survivor, Raymond James, was recently visited by Past Department Commander Ed White and Prince Georges County Commander Robert Wilson. Mr. James shared his memories of the "day that will live in infamy". Mr. James was in the Air Corps and stationed at Hickam Field, Hawaii on the day of the attack. It is perhaps no surprise to many of you that the foundations on which this country were founded have been under increasing attacks for many years. The American Legion's focus on Americanism is an attempt to reinforce those foundations. For example, The American Legion has been very involved in seeking to protect the U.S. Flag from desecration by those very people whose right to protest was earned by the sacrifices of veterans. Additionally, The American Legion strives to maintain the Pledge of Allegiance in the classroom and not some abbreviated version of the pledge, but the version that contains the words "under God". Last but not least, The American Legion sponsors many programs such as Boys/Girls State, Boy Scouts, American Legion baseball, etc., all with the intent to promote a one hundred percent Americanism in the participants.
