### **Ninth U.S. Circuit of Appeals affirms "Under God" in Pledge of Allegiance**

Although subject to appeal, the Court recently held that the phrase "under God" in the Pledge of Allegiance is constitutional. In a separate decision, the Court also upheld the use of "In God We Trust" on coins and currency. American Legion National Commander, Clarence Hill had this to say, "The American Legion was very critical, in fact outraged, when the same Court ruled in 2002 that the pledge was unconstitutional because of a phrase that has existed in the pledge since 1954. But it is time to give credit where it is due. The Ninth Circuit corrected its earlier mistake and now there is absolutely no reason why schools across the nation should not lead their students in reciting the Pledge of Allegiance every day."

### **American Legion National Commander Visits Post 259**

American Legion National Commander, Clarence Hill, along with several other National, Department of Maryland, and local American Legion officers visited Post 259 on Saturday, March 13<sup>th</sup>. While there Commander Hill toured the Post facilities and spoke with some of the members present. After a delicious crabcake sandwich, french fries, and salad dinner prepared by Mike Hunnicut, Commander Hill addressed those present and answered numerous questions from the audience.

### **Electric and Natural Gas Co-op Sign Up Now Available On-Line**

Post 259 members, Auxiliary members, and SAL members may be eligible for savings up to 18% on their electric bill and/or up to 60% on their gas bills. In large part, the potential savings is the result of the buying power of almost 300,000 American Legion members in Maryland. To determine your eligibility, go to the website [www.emaec.org](http://www.emaec.org) and follow the instructions. When asked for your organization, select 'American

Legion" from the list of pull down options, enter your Post number where appropriate, and if asked for an agent code use "EMA34". If you are asked to enter an email address for the Post, use "almd259@verizon.net". Your membership in the American Legion and Post 259 will need to be verified as a step in the process before you can enjoy your savings.
