Greetings Post 259 American Legion Family

As we continue to follow the guidelines set forth by Maryland Governor Larry Hogan, I hope everyone is safe and well. As the Covid-19 virus continues to spread across Maryland, District of Columbia and Virginia, we must adhere to all the safety recommendations: Maintain social distancing, wear a mask and constantly wash your hands.

Post 259 will remain closed until Governor Hogan lifts the Stay at Home order. I have included his proposal for opening the state in three stages in this newsletter. When you review it, you will see the post comes under stages 2 and 3. More information on when and how the post will reopen will be sent out in future emails.

The Department of Maryland American Legion recently sent out Resolution D7920 for a vote by the Department Executive Committee (DEC) requesting approval to postpone the Department Convention until on or about September 19, 2020. The resolution was adopted by the DEC. The convention location has not been determined as of this time. An email was sent out previously informing the membership the July date for the convention had been canceled and if you had reservations for that date you should cancel them.

Since we have been unable to have our March and April general membership meetings, we have not had a chance to accept nominations for officers. The AL Maryland Department sent out an email stating that post elections do not have to be completed until August 30, 2020. We have time to get the nominations and election process completed by that date.

The May general membership meeting is scheduled for May 25. This would have been the date for our Memorial Day program. Based on the current health environment and precautions, the program is canceled for this year. The May meeting will be determined later during the month.

Message from Commander Murray Hall

Maryland Gov. Larry Hogan said the state could begin reopening some businesses and gradually lifting coronavirus restrictions in May under a three-stage recovery plan he unveiled on Friday April 24 — but the reopening will only happen if the number of hospitalizations and deaths related to the virus continue on a downward trend.

Hogan announced the “Maryland Strong: Roadmap to Recovery” from the governor’s mansion, describing it as a “well thought-out, gradual, safe and effective path forward for the people of our state.”

Hogan stressed that the three-stage recovery plan lays out guidelines for a gradual lifting of restrictions.

“If we try to rush this, and if we don’t do it in a thoughtful and responsible way, it could cause a rebound of the virus, which could deepen the economic crisis, prolong the fiscal problems and slow our economic recovery,” he said.

Here is a look at the three stages:

Stage One

The stay-at-home order can be lifted

Many small businesses can reopen

Lower-risk community activities and quality-of-life improvements can resume

This stage could see the reopening of golf courses, the return of recreational boating and fishing

Elective outpatient surgeries can resume

In addition, local governments would have additional flexibility to open local parks, playgrounds, recreation centers and libraries if safety protocols are followed.

If officials do not see any spikes in deaths, ICU cases or “significant outbreaks of community transmission,” then the plan would move to the second stage, Hogan said.

Stage Two

More businesses can reopen

Nonessential workers who cannot telework can return to work

Indoor religious gatherings can resume with limited capacity

Limits on social gatherings can be raised

Can return to normal transit schedules

Restaurants and bars can open with “significant restrictions”

Stage Three

Some “higher-risk activities,” including larger social gatherings can be re-instituted

High-capacity bars and restaurants can reopen

Some restrictions on visits to nursing homes and hospitals can be lifted

Some restrictions on entertainment venues and larger gatherings can be lifted

The Covid-19 pandemic is wreaking havoc with American Legion meeting schedules. This is Section 4 – Honorary Life Members (One of three attachments sent)

SECTION 4. Life Membership Committee. The Life Membership Committee shall be composed of all honorary life members of the Post. The Chairman shall be elected by the Life Membership Committee and shall serve for a term of one year or for a lesser period of time as determined by the Life Membership Committee.

The Life Membership Committee shall act as the Nominating Committee for selecting honorary life members in the Post. At the regular Post meeting in March of each year, the membership shall be advised as to how to make recommendations for honorary life membership in the Post in accordance with the guidelines as stated below. All recommendations must be referred to the Life Membership Committee for their consideration.

The Life Membership Committee shall meet in May of each year. The Adjutant shall notify all committee members in writing at least two weeks prior, of the date, time, and place of the May meeting. In addition, the Commander, at his discretion, may call a special meeting at any time, provided the two-week advance notice is given. The Committee will submit the name of candidates (if any) selected for honorary life membership in the Post for approval at the next membership meeting of the Post after first submitting same to the Executive Committee for their recommendation.

Guidelines for selecting candidates for honorary life membership in the Post shall be:

1. It is the intention of the Post that honorary life membership is to be conferred by the Post upon a member only when the member has rendered to the Post and to the American Legion services which are in truth and in fact distinguished, that is, marked or notable, in that by performance of such service, he has become preeminent among his fellow legionnaires and thereby entitled to great honor and to special reward.
2. The candidate shall have been a member in good standing of Clinton American Legion Post No. 259, Inc. for no less than ten (10) years.
3. The Life Membership Committee of its own volition may use additional criteria in selecting candidates.
4. Life Membership Awards will be presented at the annual Post Installation.
